We, M/s. Prachi Bansal & Associates, (COP: 23670) have been appointed by Eraaya Lifespaces Limited (hereinafter referred to as 'Company'), having CIN: L74899DL1967PLC004704 and having its registered office 54 Janpath, New Delhi, Delhi, 110001 to issue this Compliance Certificate in accordance with Regulation 163(2) of Chapter V of SEBI (Issue of Capital and Disclosure Requirements), Regulations, 2018 as amended from time to time, (hereinafter referred to as "Regulations").

In accordance with the Regulations, the Company has proposed issue of 28,60,412 (Twenty-Eight Lakh Sixty Thousand Four Hundred Twelve Only) equity shares of face value of Re.1/- (Rupee One Only) each, fully paid up, on a preferential basis to Melanie Lane Partners Series Fund, LP, Melanie Lane Partners Series One, and Watch Hill Capital LLC (collectively referred to as the "Proposed Allottees"), belonging to the Non-Promoter, Public Category, at an issue price of Rs. 40.64/- (Rupees Forty and Sixty-Four Paise Only) per equity share (including a premium of Rs. [39.64]/- per share), being not less than the floor price determined in accordance with the provisions of Chapter V of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended, and other applicable laws, rules, and regulations, in lieu of their existing 2.42% equity interest in Ebix Inc. and certain other obligations i.e. for a consideration other than cash.

The proposed preferential issue was approved at the Meeting of Board of Directors of the Company held on November 14, 2025.

On the basis of the relevant management inquiries, necessary representations and information received from/furnished by the management of the Company, as required under the aforesaid Regulations, we have verified that the issue is being made in accordance with the requirements of these Regulations as applicable to the preferential issue, more specifically, the following:

 - b. all equity shares held by the proposed allottees, if any, in the Company are in dematerialised form.
- vii. Disclosures under the SEBI (Prohibition of Insider Trading) Regulations, 2015 & the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, if any, made by proposed allottees during the 90 trading days preceding the relevant date;
 - viii. Details of buying, selling and dealing in the Equity Shares of the Company by the proposed allottees, Promoter or Promoter Group during the 90 trading days preceding the relevant date;
 - ix. Permanent Account Numbers of the proposed allottees, except those allottees who are exempt from specifying their Permanent Account Number for transacting in the securities market by the Board;
